# SAMPLE BEQUEST LANGUAGE

A gift to Ave Maria Catholic Church in your will or revocable trust proclaims your confidence that we will continue to fulfill our mission and make a difference in the lives of future generations. A bequest:

- Is easy to arrange.
- Will not alter your current lifestyle in any way.
- Can be easily modified to address your changing needs.

**RESIDUAL BEQUEST:** A residual bequest comes to us after your estate expenses and specific bequests are paid:

*I give and devise to Ave Maria Catholic Church, located in Parker, Colorado, all (or state a percentage) of the rest, residue and remainder of my estate, both real and personal, to be used for its unrestricted use (or for the support of the Ave Maria Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs and/or the Ave Maria Catholic School).*

**SPECIFIC BEQUEST:** Naming Ave Maria Catholic Church as a beneficiary of a specific amount from your estate is easy:

*I give and devise to Ave Maria Catholic Church, located in Parker, Colorado, the sum of \$\_\_\_\_\_ to be used for its unrestricted use (or for the support of the Ave Maria Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs and/or the Ave Maria Catholic School).*

**CONTINGENT BEQUEST:** Ave Maria Catholic Church can be named as a contingent beneficiary in your will or personal trust if one or more of your specific bequests cannot be fulfilled:

*If (insert name) is not living at the time of my demise, I give and devise to Ave Maria Catholic Church, the sum of \$\_\_\_\_\_ (or all or a percentage of the residue of my estate) to be used for its unrestricted use (or for the support of the Ave Maria Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs and/or the Ave Maria Catholic School).*

**RETIREMENT PLAN:** You may name Ave Maria Catholic Church as a beneficiary of your IRA or other qualified retirement benefits. To make a charitable gift from your retirement plan, simply enter the Ave Maria Catholic Church name and Federal Tax ID #84-0963229 on the Change of Beneficiary Form, available from your plan administrator. Consult with your advisor to determine the benefits you would derive from such a gift.
