SAMPLE BEQUEST LANGUAGE

A gift to St. Mark Catholic Church in your will or revocable trust proclaims your confidence that we will continue to fulfill our mission and make a difference in the lives of future generations. A bequest:

RESIDUAL BEQUEST: A residual bequest comes to us after your estate expenses and specific bequests are paid:

I give and devise to St. Mark Catholic Church, located in Highlands Ranch, Colorado, all (or state a percentage) of the rest, residue and remainder of my estate, both real and personal, to be used for its unrestricted use (or for the support of the St. Mark Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

SPECIFIC BEQUEST: Naming St. Mark Catholic Church as a beneficiary of a specific amount from your estate is easy:

I give and devise to St. Mark Catholic Church, located in Highlands Ranch, Colorado, the sum of \$_____ to be used for its unrestricted use (or for the support of the St. Mark Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

CONTINGENT BEQUEST: St. Mark Catholic Church can be named as a contingent beneficiary in your will or personal trust if one or more of your specific bequests cannot be fulfilled:

If (insert name) is not living at the time of my demise, I give and devise to St. Mark Catholic Church, the sum of \$_____ (or all or a percentage of the residue of my estate) to be used for its unrestricted use (or for the support of the St. Mark Parish Endowment Fund held by the Catholic Foundation of the Diocese of Colorado Springs).

RETIREMENT PLAN: You may name St. Mark Catholic Church as a beneficiary of your IRA or other qualified retirement benefits. To make a charitable gift from your retirement plan, simply enter the St. Mark Catholic Church name and Federal Tax ID #84-1564486 on the Change of Beneficiary Form, available from your plan administrator. Consult with your advisor to determine the benefits you would derive from such a gift.
